# ENGLOSSING MILT **MEMORANDUM OF AGREEMENT BETWEEN THE** CHARIHO REGIONAL SCHOOL DISTRICT AND SOUTH KINGSTOWN SCHOOL DEPARTMENT

This Agreement is made and entered into this 15th day of February 2024 by and between the Chariho Regional School District and the South Kingstown School Department.

It is agreed that the Chariho Regional School District Superintendent may work with the South Kingstown School Department Interim Superintendent on a proposal for Chariho to utilize one of their vacant schools as the potential use of a swing space. The Chariho Regional School District and the South Kingstown School Department must approve the final agreement.

This agreement would only begin if the Voters in Chariho approve the Bond Referendum on May 7, 2024 and RIDE determines upon approval that the Chariho Regional School District is eligible to receive at least 76% reimbursement on their proposed project.

The anticipated need for the swing space is approximately spring of 2025 to August 2027.

This Agreement is the parties' entire agreement and is not subject to any terms, conditions, statements or representations not expressly set forth herein. This Agreement does not constitute practice or precedent between the parties.

Hotels and Public Places Act, Title 11, Chapter 24 of the General Laws of Rhode Island

Civil Rights of People with Disabilities Act, Title 42, Chapter 87 of the General Laws of Rhode Island

Equal Rights to Public Facilities, Title 40, Chapter 9.1 of the General Laws of Rhode Island

#### 4. Basis of Discrimination:

I was denied the services of, and/or equal access to the accommodations, advantages, facilities and/or privileges of, a place of public accommodations, based on my disability, perceived disability and/or record of disability.

#### 5. Date on which the most recent or continuing discrimination occurred:

March 2023 and continuing

#### 6. The following is a brief and concise statement of the facts regarding the alleged violation:

I am a member of the Chariho School Committee. In March 2023, the school committee voted to stop printing the agenda for its members. The school committee members are aware that I have issues with reading on the computer, including getting a headache and eye strain from staring at screens for too long. Even though I have addressed this issue to the other school committee members, they still refuse to print me a copy of the agenda.

I believe I was subjected to unlawful discrimination based on my disability. These actions are in violation of applicable state laws.

WHEREFORE, I ask that the Commission grant me such relief as shall be just and pro per.

I declare under penalty of perjury that I have read this charge and that it is true and correct to the best of my knowledge.

## RESOLUTION IN SUPPORT OF AN ACT AUTHORIZING THE CHARIHO REGIONAL SCHOOL DISTRICT TO FINANCE THE CONSTRUCTION, FURNISHING AND EQUIPPING OF THREE ELEMENTARY SCHOOLS AND ALL EXPENSES INCIDENTAL THERETO BY THE ISSUANCE OF NOT MORE THAN \$150,000,000 IN BONDS AND/OR NOTES THEREFOR

#### (BILL DATED 01/22/2024: NO BILL NUMBER ASSIGNED)

WHEREAS the Chariho Regional School District ("Chariho") is the regional school district serving the educational requirements of students from kindergarten through grade 12 for the towns of Charlestown, Richmond, and Hopkinton; and

WHEREAS the above-captioned Act being filled with the Rhode Island General Assembly seeks, in pertinent part, to submit to the voters in each member community the following question:

"Shall an act passed at the 2024 session of the General Assembly entitled, 'an act authorizing the Charibo Regional School District to finance the construction, furnishing and equipping of three elementary schools (one in each of the towns of Charlestown, Richmond and Hopkinton) and improvements at the switch road campus including, but not limited to, costs of demolition, design, health and safety projects, playgrounds, landscaping, paving and all expenses incidental thereto by the issuance of not more than \$150,000,000 bonds and/or notes therefor, subject to approval of state housing aid at a reimbursement rate or state share ratio of not less than 61% at the time of issuance, which rate or ratio may increase to more than 76% at project completion' be approved?"; and

WHEREAS the Town Council of the Town of Charlestown has reviewed the above-captioned Act and the proposed projects contained therein; and

WHEREAS the above-captioned Act provides much needed improvements to the District's educational facilities, including the demolition and new construction of the Charlestown Elementary School; and

**WHEREAS** the Town Council of the Town of Charlestown finds that the voters of Charlestown should be given the opportunity to vote on the proposed construction projects.


**NOW, THEREFORE, BE IT RESOLVED** that the Town Council of the Town of Charlestown hereby supports the public's right to vote on the Chariho Regional School District's proposed program of improvements and hereby requests that the General Assembly act favorably and pass the above-captioned Act because it affords the voters the right to decide whether to approve this undertaking; and

**BE IT FURTHER RESOLVED** that the Town Clerk is hereby authorized to provide a copy of this resolution to the Town of Charlestown's representatives in the R.I. General Assembly and the towns of Richmond and Hopkinton.

The RESOLUTION shall take effect upon passage.
